As the year closes out, I look back on 2017 and reflect on some of the improvements that were made throughout the year.

- Amended and restated declarations and By-laws
- Geese abatement
- New floating pier for the Lake
- 97.8% 2017 assessment collection rate
- Boat storage racks, abandoned boat clean up and storage/sticker revenue of \$1095.00. Goes toward boat storage unit expense.
- New step bridges in Lower Ravinia and Maple easements

So many came out on a beautiful morning and accomplished many needed tasks:

Along North Sylvan, Nancy & Scott Hanson, Renee DelMissier. Gen Connor, Linda Mihel, Paul Stempian, Kathy Ford, Laurie MacKay, Debbie Pomazal, Al Grandt, John Michnowski, (new resident in Adler's house), Terry & Rich Borst, Elizabeth Nagel, Bill Pohl, Bill Dolbee, Sandy Washburn and Anibal DelaCruz removed LOTS of buckthorn and honeysuckle.. They then herbicided the stumps and performed general cleanup of leaves and trash. Who is depositing dog poop in the tree stump on North Sylvan? PLEASE take it home and throw it away!

Dan & Sandy Washburn donated 2 pier sections to our association. Al Grandt, Bill Pohl, Sam Ford, Evan & Andy Kitzmiller helped to move these from the Washburn's driveway and take them down into Ravinia Park where they will be used to extend a walking path that already has one pier section. This elevates traffic off the soggy bottom.

Earlier in the week Al Grandt and Dan & Andi Dickinson moved fire wood out of Maple Park and transported it to Schwerman Park for the Oktoberfest. Mark Anderson & Uwe Moeller spread new gravel on the path so this could happen and also so people could use this path once again

after it was washed out from the historic rains we had.

On Sat. January 13th 2018,


a group of us Parks/Easements/ Environmental gals will be removing more buckthorn along the fenceline. If its 30 degrees or warmer, come join us. We'll start @10:00am. If you have buckthorn and honeysuckle on your property, this is a good time for removal. After cutting it down to the ground, apply Round-Up to the fresh cut- scoring the cut also helps it to absorb, like a criss cross, then apply Round-Up either spraying directly on the scored stump or using a paint brush. Sometimes that is easier, pour some in a jar, dip the brush in, less waste from over spraying. These species are dormant in winter and they are pulling moisture down to the roots, rather than shooting moisture up the trunk as happens in the spring to feed new growth.

Spreading native flowering seed in winter is good too, either sweep some snow over the seed, or rake some leaves over them and walk over the leaves to help keep them in place. As the ground thaws it draws the seed to the dirt in a very natural way, and BOOM, seeds sprout!

Our group also discussed forming a Kids Environmental Group, anyone interested in helping this along?



ECO-CORNER #2

Freeze-Salt-Thaw-Repeat:

We are never sure what freezing weather and precipitation we'll ultimately get throughout the



Rock salt (sodium chloride) has been a common and low cost option to melt ice since the 1940s, and although it is a natural product mined from the earth, that product is often overused which can result in damage to surrounding land and water environments. Once sodium chloride enters an ecosystem, it can be diluted - but it never leaves. Excess salt can easily wash away to deposit into neighborhood easement lands and can ultimately raise the chloride levels in our Sylvan Lake. This has the negative potential to limit or extinguish aquatic life and vegetation vital to the health of our lake water quality and shorelines.

Data from the Metropolitan Water Reclamation District of Greater Chicago suggests that it takes only 1 teaspoon of road salt to permanently pollute 5 gallons of water! Salt dust and residue on land can also chemically burn or kill nearby plants - not to mention irritate the feet of pets - and contaminate the ground surrounding trees and bushes. Some soils can become toxic enough over time such that very little will grow come the warmer months. As a side note, the Chicago Botanic Garden does not use sodium chloride (salt) on the property, and has not for at least 27 years.

There are other de-icing products on the market that are generally considered more eco-friendly than road salt, so at the start of this season perhaps we could learn more about the chemicals we plan to use in de-icing our yard areas and, in addition, be mindful of the amounts we throw on the ground. As scientists voice growing concerns about the environmental impact of the (over-) use of rock salt, we have a unique opportunity to directly manage and positively influence the overall health of our Sylvan Lake neighborhood land and water ecosystems. The outcomes of doing so can show a benefit across all seasons!

JOB PROGRESS AND COMMENTS

We began working at Ravinia Park and focused on invasive woody species. Larger individuals were brushcut and followed up with a stump herbicide treatment. Small woody species that were still green were foliar sprayed. The area closest to the road was focused on. Our previous foliar application to small woody species proved very successful and today was a good follow-up. It appears some shrubs were recently cut by somebody else, potentially homeowners, as the leaves on these downed individuals were still green. These sites are in overall good shape with native species dominating the ecosystems. Ravinia Park has undesirable woody species throughout. Maple Park has seen non-native woodys species removed from the interior of the site though more individuals persist on the fringes The most problematic non-native species at both sites are woodies which are recommend for removal this winter before they get larger and drop more seed. We saw very few exotic thistles at each park and sprayed the few (<10) that we encountered.

Snow Plowing and Parking

When Fremont Township plows your roads this winter it allows for better and safer snow removal if the plows do not have to go around vehicles that are parked on the road. Please do not park on the street to allow the plows to get through safely.



Fremont Township maintains over 40 miles of road including the roads in Countryside Lake, Fremont Manor, Sylvan Lake, West Shore Park, Oak Terrace, Barnswallow, Pond Shore, Summerhill Estates, Ivanhoe Road, Erhart Road, Chardon Road, Milton Road, The Woods of Ivanhoe and more!
